

Rationale

Southern River College supports students to independently develop skills of growth mindset and excellence to build outstanding citizens of the school and community. An important part of this process is Teaching students to be accountable for their behaviour and choices and realise there are consequences attached to these.

Southern River has developed a comprehensive Good Standing policy underpinned by 'RIVER way'. The RIVER way clearly articulates a set of criteria that, if demonstrated in excellence, rewards students and provides them with extra-curricular privileges. However, those students who do not meet the set requirements will have these privileges removed through a loss of Good Standing and will be required to demonstrate ownership and growth to have Good Standing returned. In line with required actions of ["Standing together against violence"](#) and [Connect and Respect](#) any student that initiates, participates, films or threatens violence will lost Good Standing status.

All students who are enrolled at Southern River College obtain Good Standing once they commence their education at the College.

Aim

- Recognise and celebrate students who consistently demonstrate RIVER values
- Positive reinforcement to encourage productive behaviour, attendance and engagement
- Communicate to parents/guardians optimal conditions for engagement and learning
- Whole school pastoral care responsibility

Implementation

Students will retain their Good Standing through demonstrating the 'RIVER Way' with a specific focus on celebrating success in:

- Attendance – Demonstrating 85% or above school attendance. 80 – 85% with 0 unauthorised absences.
- Behaviour – Consistently demonstrating to criteria outlined within the RIVER values: Respect, Identity, Virtues, Excellence and Responsibility.
- Participation – Positive engagement in all course curriculum and consistent completion of assessment requirements.
- Digital devices – Student consistently demonstrates adherence to DOE policy for mobile phones and other digital devices.
- Uniform – Wear correct College as outlined within the Southern River Conduct Policy
- Vaping – No vape related incidents.

Students that have Good Standing are eligible to participate in all extra-curricular activities/excursions that are offered to their demographic. These activities include but are not limited to:

Social events (discos, river cruise or school ball) · Excursions · Camps · Carnivals · Expos · Representation

of the College at external activities · Reward Activities · Focus programs · Leadership roles · Year 12 Graduation and Award Ceremonies · School performance nights.

APPEAL OF LOSS OF GOOD STANDING OR EXTENUATING CIRCUMSTANCES

An appeal of the loss of student’s Good Standing can be made in writing to the Head of Year within **5 days** of parent(s)/guardian(s) receiving notification of the loss of Good Standing. The appeal may be considered by a review panel. Deputy Principal/staff member with designated authority to determine outcome of appeal.

Loss of Good Standing from Suspension or major breaches of school rules

1. Good Standing may be returned on a case by case basis. Head of Year to review conduct in College and where appropriate consult with Wellbeing Program Coordinator/Deputy Principal.

PROCESSES

- Homeroom Teachers to monitor Good standing weekly and communicate risk/loss to students and parents or guardians – attendance, uniform, ICT. All other losses are communicated through Wellbeing Team e.g. Behaviour, suspension
- End of Week 7 email sent to all Homeroom Teachers to send list of students liable for Good Standing
- Homeroom Teachers have 1 week to send through and then students that are notified of loss on Friday of Week 8 have 1 week to appeal loss Good Standing
